ACCESSIBILITY PLAN AND POLICIES

Statement of Commitment

Ben Machine will review its website and content and make the necessary changes to ensure that it conforms with WCAG 2.0, Level AA by January 1, 2021.

Employment

Ben Machine is committed to fair and accessible employment practices. We will notify the public and staff that, when requested, Ben Machine will accommodate people with disabilities during the recruitment and assessment processes and when people are hired by posting a copy of these policies on the employment notice boards in the company.

Ben Machine will develop individual accommodation plans and return-to-work plans for employees that have been absent due to a disability. These plans will be created in consultation with the employee and any required third parties, including the employee's health care providers.
